PROFILES



MRS. CAROLINE CHUMA ZULU SOKONI

is the current Public Protector of Zambia, has served in the office of the Country's National Ombudsman for fifteen (15) years. She began her professional career in 1989 as a State Advocate under the then Ministry of Legal Affairs (now known as Ministry of Justice). She has a Masters of Law in Criminology from Queen Mary and Westfield College, University of London in the United Kingdom and served under the Ministry of Justice for fifteen years. She was appointed as Acting Director of Public Prosecutions for the Republic of Zambia in February 2004 and was also appointed as the Task Team leader for the Legal component of the Water Resources Management Project, a policy formulation body tasked to spearhead the reform of the Water Resources Management process in Zambia. She presided over the Town and Country Planning Tribunal as the Vice Chairperson between 2003 and 2005. In November 2004, she was appointed as the Investigator General for Zambia's National Ombudsman Office. At the time of her appointment the Office was known as the Commission for Investigations.

ADV. TŠELISO MOKOKO

is the Ombudsman of Lesotho since June 2019. He graduated from the National University of Lesotho, having obtained LLB, and was duly admitted as an Advocate of the High Court of Lesotho and Courts of Lesotho in 1999. He currently serves as the Ombudsman. Shortly after his admission, Adv. Tšeliso Mokoko was employed in the civil service, at the Ministry of Justice, placed at the Legal Aid as the Legal Aid Counsel. The main mandate of that office was to represent indigent people in all the courts of Lesotho, for a variety of cases and to offer legal counselling to clients. Around 2003, he resigned from the civil service and joined private practice, wherein he dealt mostly with civil matters. In August 2017, he was appointed as the Principal Secretary in the Ministry of Local Government and Chieftainship. Around May 2018, he was transferred to the Ministry of Defence and National Security. He was thereafter appointed as the Ombudsman in June 2019.



COMMISSIONER ELASTO HILARIOUS MUGWADI

is the Chairperson of the Zimbabwe Human Rights Commission (ZHRC). He is also the Vice Chairperson of the Network of African National Human Rights Institutions. He was sworn into office in 2010 with the first group of Commissioners and became the Chairperson of the ZHRC in 2014. He holds a Bachelor of Administration (Hons) degree from the University of Rhodesia and a Master of Science degree (MSc) in International Relations. He also holds a Diploma in Development Studies from the University of Oslo, a Degree in Law LLB (UNISA) and LLM (UNISA) and a Doctorate in Human Rights and Humanitarian Law from the Commonwealth University London. He is also a former Chief Immigration Officer of Zimbabwe having worked at the institution for 23 years. Commissioner Mugwadi is also a legal practitioner at Mugwadi and Associates since 2007.

MR. TANON DAOUDA

is the Executive director of the "Mediateur de la République" of Côte d'Ivoire. He is a retired economist and financial services administrator of exceptional calibre. He holds a Master of Arts in Economics from Long Island University (Brooklyn, New York, USA); a Post-graduate diploma from the "Ecole Nationale des Douanes" (Neuilly-sur-Seine, France); and a Bachelor's degree in Economics from the University of Abidjan, Côte d'Ivoire. His rich professional experience includes, but not limited to, economist - Independent consultant in feasibility studies; Directorate of Administrative and Financial Affairs of the Ministry of the Economy and Finance; Director of the Economic Office of Côte d'Ivoire, in Paris, France; Chief of Cabinet of the Ministry of Economy and Finance; Director of the Côte d'Ivoire Economic Office, Ivory Coast Development Office in New York, USA; and Director of Financial Services Direction Générale des Douanes, Abidjan, Côte d'Ivoire.
